- Factor environmental considerations into investment decisions, equipment purchases, and operational processes.
- Train and inform all employees and subcontractors on Handy Rubbish's environmental objectives and how they can contribute.
- Use environmentally friendly cleaning and operational products wherever feasible.
- Explore opportunities to offset carbon emissions through reforestation and other carbonreduction initiatives.

Targets

- Regular internal checks on environmental practices across all operations.
- Ongoing monitoring of environmental objectives and performance against KPIs and targets.
